IN REP. CALVERT'S CONGRESSIONAL DISTRICT 41

In 2025, **Congressional Republicans** are focusing their legislative efforts on extending the 2017 Trump tax cuts. To pay for these tax cuts, Congress is planning major cuts or rollbacks to federal programs, including Medicare, Medicaid (Medi-Cal in California) and Affordable Care Act marketplaces like Covered California. The majority of Californians rely on these programs for their health care coverage. Cuts that would gut and dismantle these crucial programs and take away life-saving health care coverage and access for millions of Californians will ultimately lead to unnecessary suffering, illness, and death.

MEDI-CAL

Nearly 15 million Californians depend on Medi-Cal, which provides free health care, dental care, vision care, mental health care, substance use disorder services, and long-term care to low-income families, seniors, and people with disabilities across the state.

In Congressional District 41, Medi-Cal enjoys wide bipartisan support, with 61% of voters viewing it favorably. Because of this, district voters oppose cuts to Medicaid by a 28-point margin.¹

In the 41st Congressional District, 256,000 people are enrolled in Medi-Cal, which is 34% of the people in the district.² This includes a staggering 98,000 people between the ages of 0 and 19, **which means nearly 5 in 10 kids represented by Congressman Calvert are served by Medi-Cal.**³

A cut to Medi-Cal is also a cut to Medicare: Medi-Cal pays for services Medicare does not cover. It is the primary payer for long-term services and supports and pays for unaffordable Medicare out-of-pocket costs like premiums, co-pays, and co-insurance. In Congressional District 41, there are over 25,000 people who are eligible for both Medi-Cal and Medicare. Many of these are folks who are low-income seniors and people who are disabled and rely on these programs for survival. Any cut to Medi-Cal will impact them even if Medicare is left untouched.⁴

In total, \$2.9 billion Medi-Cal dollars are being spent to cover kids, working adults, seniors, and disabled community members in the district.⁵ This benefits not only the patients served, but also bolsters the stability of fiscally vulnerable health care providers. A facility closure could impact the whole community, not only lowering access to care, but reducing jobs and creating a ripple effect on the local economy.

COVERED CALIFORNIA

California's state-based health care marketplace, Covered California, fills a key gap for those that earn too much to qualify for Medi-Cal, but do not get their health coverage through their jobs. Federal and state financial assistance make this care affordable for individuals and families.

In Congressional District 41, 33,000 people receive their coverage through Covered California.⁶ This includes 26,000 people who benefit from the current federal enhanced subsidies that ensure that no one pays more than 8.5% of their income on premium costs - with most paying much less. If this premium assistance is not extended by Congress by the end of 2025, premiums for residents in CA-41 will spike 46%, an average of about \$100 per month.⁷ The longer the subsidies are delayed in Congress, the more likely there will be an impact on consumers next year. California has also helped to offset other costs like deductibles and co-pays for tens of thousands of Californians, removing more barriers to care. If the federal assistance for premium subsidies does not continue, California will likely not be able to continue this assistance, and out-of-pocket costs will also skyrocket.
